## Minutes of Internal Quality Assurance Cell Meeting held on 15.6.2021

The IQAC Coordinator discussed the following points during the meeting:

- The research performance and key ranking parameters of the faulty such as papers, citations, papers without sources, international collaborations, and vital ranking ratios such as papers/Faculty, Citations/Faculty, H5-index, etc., for the academic year 2021-22 must be in line with the requirement.
- A seed Money application must follow a predetermined format. It must include a recognized letter of inclusion, requirements for the research topic, and allotment letters, and the project and fund transfer details must be certified.
- Ecosystem implementation with the budgets is only accepted. Record of MOUs with private holders is mandatory.
- The department-level coordinators must collect and submit the data and proof to the institutional coordinators. They must compile the data as per the required format at the earliest, which will help prepare the AQAR report for the current academic year (2020-2021).
- The coordinator mentioned there would be reviews in the submission process as the portal is dynamic, and the NAAC experts will verify the link documents.
- During the submissions, the Principal posed questions, and after further elucidation, the AQAR report has uploaded to the NAAC portal.
- AQAR report for the academic year (2020-2021) resubmission entry was opened in the NAAC Portal for further improvement till March 15th, 2022.
- The IQAC coordinator has planned to organize a Mentor-Mentee workshop for

the faculty to foster their learning skills.
